

# Library Parcel Tax Exemptions for Seniors - Application 2023-2024

2015 - Measure A: County Library Special Tax Senior Exemption

1994 - Measure K & L: Senior Low-Income Exemption

Apply by 06/01/2024 for Current tax Fiscal Year

This application serves to request Measure A - County Library Special Tax Senior Exemption.

**Senior Exemption (Measure A)** - To qualify for a **\$61.08** County Library Special Tax Senior Exemption for a single family residence, **you must be 65 years of age or older by December 31 of the tax year 2023**, own and occupy your residence located in the Measure A tax zone of the Marin County Free Library District.

**Senior Low-Income Exemption (Measures K & L)** - To qualify for a **\$36.00** Senior Low-Income Exemption for a single family residence, **you must be 65 years of age or older by December 31 of the tax year 2023**, own and occupy your residence located in the Special Tax Zone #2 of the Marin County Free Library District or the Town of Corte Madera, and earn a total annual household income\* of not more than **\$78,522** (80% of the median income for Marin County Residents who are 65 years and older). Note there is no Senior Low-Income Exemption available for FFX / W. Marin Library Zone #1 area.

**An application must be filed on or before June 1, 2024.** Failure to file in time will result in rejection of your application for exemption unless good cause can be shown for failure to timely file.
