Brown Act:

The legislative body of a local agency may use teleconferencing in connection with any meeting or proceeding authorized by law. Cal. Gov't Code §54953(b)(1). A "teleconference" is "a meeting of a legislative body, the members of which are in different locations, connected by electronic means, through either audio or video, or both." Cal. Gov't Code § 54953(b)(4). A local agency may provide the public with additional teleconference locations. Cal. Gov't Code § 54953(b)(4). The teleconferenced meeting must meet the following requirements:

(1) it must comply with all of the Act's requirements applicable to other meetings;

(2) all votes must be taken by roll call;

(3) agendas must be posted at all teleconference locations and the meeting must be conducted in a manner that protects the statutory and constitutional rights of the parties or public appearing before the body;

(4) each teleconference location must be identified in the notice and agenda and each location must be accessible to the public;

(5) during the teleconferenced meeting, at least a quorum of the members of the legislative body must participate from locations within the boundaries of the body's jurisdiction; and

(6) the agenda must provide the public with an opportunity to address the legislative body at each teleconference location. Cal. Gov't Co).

Throughout the **Teen Summer Program** (June 18th-July 16th, 2022), our libraries gave away nearly 600 books and 800 craft kits! Our kits included: **Origami Zoo, Beginner Embroidery,** and a **Tiny Art Show**. Kits were distributed in our branches, local schools, farmer's markets, and youth serving community organizations. Craft kits were assembled by librarians and teen volunteers and generously funded by the Friends of the Marin County Free Library. Giveaway books included new and popular titles in multiple languages to serve our diverse community of teens in Marin.

We also distributed bookmarks created by our in-house marketing team to showcase the **Teen Tough Topics Collection**, our **Digital Resources**, and **Mental Health Resources**. Some branches also gave away Giants baseball tickets this year.

Work continued on the **Teen Leadership Crew**'s zine, **The Spire**. Teen volunteers have been hard at work producing and editing content created by and for teens, which will be published sometime this year.

Adult Services







August brought on a surge of new in-person events in our libraries!

Fairfax Library began hosting **Climate Café**, a drop-in compassionate sharing circle on Saturdays, open to all people/all ages that may be feeling distress about the climate crisis and the impact at the global, local or personal level. It will be an opportunity for community members to share their thoughts in a small safe, non-judgmental and advice/agenda free circle of listeners.

Do you have clothing items that need repair? Want company while you mend? Patrons like you are now invited to bring your projects to the Inverness Library and join their **Mending Circle**. The group will be meeting every other Monday from 5 to 7 pm in the Jack Mason Museum Room.

Calling all Quilters, Sewing Sirens, Mending Divas, Knitters, Spinner and Crocheters - You can now bring your project(s) to work on in a fun and lively social environment at the Fairfax Library on the 2nd Monday of each month for their **Fabric and Fiber Makers' Club**.

An exhibit **"a lily is a poem"** by Sophie Wood Brinker, celebrating local Calochortus lilies, was on display for the month of August at Stinson Beach Library and kicked off with an Opening Reception August 5th.

Two important **online programs** were also presented in August:

Intuitive Writing: A Workshop with Susanne West explored writing as a transformational tool to help you access your inner wisdom. Participants learned a variety of processes and had opportunities to bring their life questions to this boundless source of knowing and guidance within them. Susanne West is a writer, poet, professor of psychology and spiritual mentor. She is the author of <u>Soul Care for Caregivers</u> and the poetry collection, Subterranean Light.

Members of Marin County's Financial Abuse Specialist Team (FAST) offered an online presentation for older adults about how to **Avoid Scams, Fraud, and Identify Theft**. FAST provided information on how to avoid financial abuse and protect against common financial scams. FAST volunteers have expertise in accounting, law, business, and banking. They provide community education and offer training to organizations on how to recognize and prevent financial abuse. In 2019, Marin FAST was the recipient of the Aging Achievement Award from The National Association of Area Agencies on Aging.

Our collection includes tools and devices, as well as more traditional formats. Our team has recently been acquiring and adding more <u>Tech</u> <u>Connect Packs</u>, with Chromebook laptops and hotspots, as well as other hotspots purchased with Emergency Connectivity Grant funds, to support our communities with limited Internet access.

These are available to borrow, for free, with your library card. The goal is to provide more opportunities for those who lack Internet connectivity to use digital resources to learn and explore using these devices.

Technical Services folks have recently acquired books for special projects, including giveaways supported by the Friends of the Marin County Library and Library Foundation for sharing at the opening of "The Legacy of Marin City" exhibit at the Marin Center Bartolini Gallery. We also purchased more copies of "<u>Grandmothers Feed Us Love</u>", a book created in honor of the family traditions of the community of Marin City, for our collection.

A local history book about Nicasio, "<u>Nicasio's Oldtimers, Newcomers and</u> <u>Remarkable Guests</u>," was acquired from the Nicasio Historical Society. Books to prepare for the StoryWalk project were also purchased: "<u>Agua,</u> <u>Agüita</u>" by Jorge Argueta and "<u>The Hike</u>" by Alison Farrell.

The <u>First Partner's Summer Book Club</u> materials, a free bookshelf of diverse children's book titles provided by the California State Library, were received, and processed to make available in all branches. The bookshelf includes a mix of titles with characters from diverse backgrounds and experiences, titles created by California authors/illustrators, and titles with a social emotional focus.

Point Reyes Library hosted a Starlink distribution event with Parent Services Project on Friday, August 12 as part of the **Shoreline Connectivity Project**. 6 local families living in rural areas received their devices that day and connected to the internet for the first time. 25 Shoreline Unified School District families have now received internet connectivity as part of this project.

Inverness Library had an **interactive children's play area** outside the library at the **Inverness Fair** on Saturday, August 13. Three invaluable teen volunteers assisted with button making, games, and crafts. Free giveaway books were available for families who attended. Inside the library was also a hub of family activity!

Planning for the new academic year of **Reading Buddies** at Point Reyes and South Novato Libraries is underway and will start in early September.

The Learning Bus and Bookmobile teams had a fabulous and busy summer! Kicking off the fun and learning at the Marin County Fair with lots of books and hula hoops!

In partnership with First 5 Marin, the Learning Bus provided 2,385 free books, purchased by the Friends of the Marin County Free Library and 2,000 Early Learning Tote Bags with learning materials purchased by First 5 Marin. Inside the Early Learning Tote Bags, children found a variety of art and school supplies such as watercolors, coloring and writing tools, playdough, glue, scissors and more. With these books and materials, First 5 Marin and MCFL hope to provide children with tools to promote learning and reading at home and get them ready for school.

MARINet Board Meeting – Minutes Online Meeting – July 7, 2022 12:00 p.m. to 2:30 p.m. Approved on Aug. 4, 2022

Meeting convened at 12:25 p.m.

Public Comment: Bill Hale has two comments. First, he says that libraries should be at the forefront of efforts to combat disinformation. ALA should take the lead. Second, a legal case access to materials just came down, are libraries locally ready for that? Third, to comply with the Brown Act, if items are action items or not action items needs to be more clear. We need the Brown Act training.

Minutes of June 2 and June 9 meetings are approved unanimously.

Report of the Cost Sharing Working Group: Survey responses came in right up to today. The average satisfaction with the current formula is 6 out of 10. The group looked at alternative bases for funding. Ideas included tiered services, or maybe larger libraries do pay more. How to introduce equity? And should the library's budget be considered as a factor? Any new approach could be brought in as a tiered thing to lessen the impact.

Comments, Gary says the academic libraries have a special deal, they don't benefit from many of the things MARINet does, Henry confirms a separate category for the academics. Abbot says it's tough to reconcile the well-off and not well-off libraries. What is MARINet? What are we paying for? Should we compensate libraries with low-income communities? How are we serving the whole of Marin County? Sarah says that COM is considering moving to Alma, as it's free for all Community Colleges in the State.

There are two tracks to this, adjusting the formula, and reducing the budget. Who can pay more, who needs to pay less? Relying on what can work for people? County talking to schools, they pay MCFL for some services now. Dan's comment: 18 % of the budget is Overdrive, or \$350k this year. \$100k is linkplus, \$100k is CENIC. Dan will provide updates on what these large contracts look like.

Regionals Working Group: no report, next month.

LBGTQIA Affinity Group: Motion made to authorize staff group with this name to meet, seconded, vote to approve is unanimous.

Product Presentation: Digital Navigator, presented by Chrisitian Theyer. This system assesses the needs of patrons and sets them up with free connectivity resources that the government is providing. It's a part of the Connected California project. They connect patrons to resources and devices for free or low-cost internet, and promote basic digital literacy. It's less of a tech support role and more social services. Digital Navigator supports Spanish and English directly, and may add translation services beyond that. Libraries are not expected to survey the clients, collect any data, or participate financially.

Digital Navigator is not keeping any identifying data on patrons, except names and ZIP Codes, and can purge those if needed. Among many overlapping services, Navigators try to find the best services they can for each patron. Outreach kits are coming out in a month. Send Christian who the point person in each system is. No need for a vote, just volunteer to take part. In Marin our ZIP Codes don't align with library jurisdictions exactly, is that an issue?

Aspen demo: Discussion around the table of benefits and costs. Reduced costs are estimated at \$15k to \$20k per year, the biggest impact would be retraining patrons. In discussion, several libraries indicate they are not interested in changing the catalog right now, no motion is made. Henry asks, then what do the next steps look like? Who do we need to talk to for moving this decision along? Maybe DRWG? Consensus is that the board could probably make the decision by themselves, if they desired. Is the uniquely branded portal that Aspen offers enough to sway people? Anji offers that if we do go to replace the public catalog we need to broaden the exposure of the proposed product so staff would be on board with this process, one which affects them this much.

Discussion continues, if there are cost savings, what's the balance with the pain of suffering of staff changing things? MCFL has an election in November, and doesn't want to change interfaces people use to access collections right, especially as it would render their new website obsolete. Sarah says from their perspective, it's nice to see "MARINet" on the catalog, they don't need a branded version.

Crystal asks, what are MARINet's goals? Is there a list anywhere? Anji says we could have a one-year plan to prioritize things. This will go back to the executive committee and then back to this meeting next month.

Collection HQ: We have a quote for CHQ a couple months ago, and MCFL and SRPL would get refunds for their recent subscriptions as they fold in. Motion made to pick up CHQ for everyone. Yes vote is unanimous. Related issue, should we drop Decision Center? It would free up the same amount of money, though we have just now trained MCFL admin to use it for specific projects. Decision about whether or not to drop Decision Center is deferred.

Quipu: We need to replace Library Market for verified online cards, and have a quote from Quipu. A placeholder for this is in the passed FY23 budget for \$17k, this will cost us around \$18.5k to implement, but is only \$3.5k a year after. (Less than Library Market, at \$1 a card we were up to \$6k/year.) A motion made to change vendors to Quipu: motion seconded, vote yes is unanimous.

E-commerce and fines: Push discussion back to next month. **Collaboration Standing Item** also postponed.

Equity discussion: Access issues? Buildings, construction, but also involves neuro diversity and more eclectic issues that block access for people. Good example from San, someone asking for an elevator, when they have one. They increased the signage. And added 10 minute express parking in front of library. Points back to who are we not serving? The schools have higher expecatations around physical access issues, but for ecample COM has a whole office that handles this for the campus.

Systems Report: Fines piad are being distributed now, and total \$18,000 for the whole year. Checks to each library are going out next week. MCFL is paid with ETF so that's done.

Future topics: break on the agenda,, 10 min for future.

Announcements:

Belvedere Tiburon opens fully (the whole building) pm Sept. 17.

College of Marin is in Sumer session now. They are planning on having banned book events this year.

Dominican's Library is moving to the other side of building during remodeling. Gary can't wait till we get back to visiting other people's libraries once again.

San Rafael has lots of new stuff available, due to the Pittsburg Family Foundation.

Marin County is asking the Board of Supervisors this month for direction on the parcel tax renewal, and the library is hoping to be on the November ballot with it.

Sausalito Library just did a big e-book purchase with other libraries. Abbot will be taking a 3 week vacation soon, for the first time in 3 years.

Mill Valley Library will help the County in any way possible with the funding measure. Patrons don't know who is what library sometimes.

San Anselmo Library is also doing a parcel tax renewal measure in November. They've also launched the OWLS for homebound patrons.
